

Forensiese Rekenmeesterskap



Forensiese rekenmeesters is betrokke by die voorkoming, opsporing en ondersoek van kommersiële misdade (soos bedrog, korrupsie en geldwassery). Forensiese rekenmeesters benodig vaardighede en kennis in rekeningkunde, straf- en siviele reg, ondersoeke en IT-vaardighede (digitale bewyse-insameling, en data-analise) om forensiese ondersoeke uit te voer.

Ondersoeke kan die volgende insluit: regulatoriese ondersoeke (bv. Ponzi-skemas en geldwassery) of kriminele en siviele ondersoeke (bv. kwantifisering van verliese). Verder is forensiese rekenmeesters betrokke by strategieë om ekonomiese misdaad te voorkom soos bedrogrisiko-assesserings en forensiese data-analise.

Forensic Accountancy

Forensic accountants are involved in the prevention, detection and investigation of commercial crimes (such as fraud, corruption and money laundering). Forensic accountants need skills and knowledge in accounting, criminal and civil law, investigations and IT skills (digital evidence recovery and data analytics) in order to conduct forensic investigations.

Investigations can include regulatory investigations (e.g., Ponzi schemes and money laundering) or criminal and civil investigations (e.g., quantification of loss of profit claims). Furthermore, forensic accountants are involved in strategies to prevent and detect economic crime such as fraud risk assessments and forensic data analytics.

Characteristics of Forensic Accountants

- They like to interact with other people
- Are analytical
- Are inquisitive
- Seek intellectual challenges
- Strive for fairness

Career options

- Private practice
- Internal forensic divisions at corporates such as banks, insurance companies, mining companies, etc.
- Forensic divisions of government institutions and regulatory bodies (e.g. SARS, the Financial Intelligence Centre)
- Forensic divisions of auditing, consulting or legal firms

What are the admission requirements for Forensic Accountancy?

- APS score of **36**
 - Mathematics level **5** (60-69%)
 - Language at level **5** (60-69%)
- * BCom Forensic Accountancy is only presented in Potchefstroom in Afrikaans and English
- ** BCom Forensic Accountancy – 3 years, full-time
- *** Hons. BCom Forensic Accountancy – 1 year, full-time
